Mr. Sucharitakul is currently an adviser to the office of Her Royal Highness Princess Maha Chakri Sirindhorn of Thailand, a position he has held since 1987.

In 1990, Mr. Sucharitakul was appointed director of Thai Red Cross Children’s Home, an organisation providing assistance for abandoned new-borns and children. In 2002, he was appointed director of Professional Waste Technology (1999) Public Co. Ltd., which collects waste and disposes of hazardous and non-hazardous industrial waste, chemical wastewater, and biological wastewater. In 2007, he served as Chairman of Siam Power Generation, a license-holder to build, operate and own power-generating plants under the Small Power Producer programme which operates 160MW Combined Cycle Gas Fired Power Plant in Rayong Province, Thailand.

Commenting on the appointment, Dr. Sri Hartati Kurniawan, Chief Executive Officer of AAA said: “We are pleased to welcome Mr. Sucharitakul as the Company’s adviser. We are confident that his background, network and experience will bring valuable contributions to the Company.”
